Outpatient Mental Health & Substance Abuse Treatment Services are available across Southeastern Massachusetts through High Point Treatment Center's comprehensive continuum of care.

High Point's outpatient clinics offer a broad spectrum of mental health and substance abuse services designed to meet the individual needs of the client. Diagnostic assessments are conducted, and individual, group, and family counseling are provided. Psychological and/or psychiatric evaluations and medication management also are included to promote recovery and emotional well-being.

High Point also addresses the needs of domestic violence victims through the South Shore Women's Resource Center (SSWRC) in Plymouth. Supportive, confidential prevention, intervention, and advocacy services are available at no cost to women and children at South Shore Women's Resource Center.



Educational services are available for clients mandated to attend drug and alcohol education programming as a result of driving while intoxicated, as well as for clients required to attend as a stipulation to return to work or school.

OUR TEAM OF PROFESSIONALS

Care and treatment is provided by an interdisciplinary team of professionals, including psychologists, psychiatrists, clinical nurse specialists, licensed social workers, Master's level mental health clinicians, and certified addiction counselors.

REFERRALS AND FEES

High Point accepts referrals from clients, state agencies, and other health and human service providers. Payment for services is accepted from most insurance companies and self-payment. A reduced fee/sliding scale payment is offered for clients who qualify.
